## Release Form

Further I certify that my boat is in good condition, has adequate flotation fore and aft to support all occupants in the case of capsizing or swamping, and that one Coast Guard approved personal flotation device will be carried on board for each occupant.

I understand that the race course may cross shipping lanes and that I am responsible for yielding the right-of-way to all other vessels.
